**THIS DEED OF TRUST** has been executed on this the 30<sup>th</sup> day of October 1982.

**WHEREAS**, the founder Trustees of THIS TRUST DEED, have decided to afford Rs. 2000/- (Rupees two Thousand Only) as to the total of Rs. 50,000/- (Rupees Fifty Thousand Only) being the principal amount and build a Marriage hall (Kalyana Mandapam) for the use of public in Somanur and administer the trust as per the rules and regulations of this deed of trust.

1. Name of the trust: SOMANUR KONGU VELLALAR TRUST
2. Trustees shall mean the Trustees of this Somanur Kongu Vellalar Trustees.
3. **In order to carry out the under noted objects / objectives/ aims/ goals/ projects objective, the trust shall undertake the following Objectives**
  - a) To build a Marriage hall (Kalayana Mandapam) in Somanur for the benefit of public and let it for their marriage purpose.
  - b) To establish, manage, run, takeover or to assist in establishing running and managing educational institutions for the needy and the deserved and to provide financial support for education.
  - c) To conduct Seminar and debate regarding education.
  - 4) To collect donation from public for trust and shall appoint the person who work for the welfare of the trust as its trustees and it shall be approved by the founder trustees and however that the total number of trustees shall not exceed Twenty Five at any time.
  - 5) This trust shall consist of the founder trustees along with other trustees as said in para 4 of this deed. The founder trustee shall have the right to appoint a member of his family as trustee, during his period or his family members shall have the right to be appointed as trustee. If any member has not been appointed as trustee as said above, the trust members shall elect one as their trustee. It is applicable even for the founder trustees.

6) This trust shall be administered by the below trust executive committee (7 members) from the date of execution of this deed of trust

7) The trust executive committee shall hold their post for a period of 5 years and once in 3 years the committee of trustees shall appoint the trust executive committee.

**8) Appointment of executive committee**

The trustees shall elect 7 members out of the trustees by their majority as executive committee. The elected executive committee shall hold their post for 3 years.

9) The trustee executive committee shall fulfill the temporary vacancy of executive committee.

10) The founder trustees shall contribute Rs.50,000/- in the name of the Trust for constructing marriage hall (Kalyana Mandapam)

11) The trust shall spend the amount contributed by the founder trustees, donations, properties of trust and income derived out of the properties of trust, only for the benefit of trust and charitable functions.

**Powers of executive committee**


12) The executive committee shall have power to appoint labours for trust, fix and pay salary for them, and if necessary dismiss them.

13) The treasurer and secretary shall have the right to collect the fund on behalf of the trust and issue receipt on behalf of the trust.

14) The cash received on behalf of the trust shall be deposited in a Nationalized bank as decided by the executive committee and 2/3 out of executive committee president, secretary, treasurer shall sign to withdraw amount from the account. The treasure shall have up to Rs. 5,000/- only in hand for day to day expense of the trust.

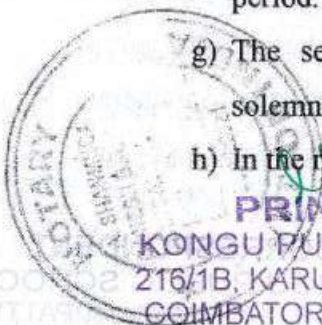

- 15) All the expenditures must be done in the name of trust.
- 16) The trust is authorized to run and manage the enterprises or business/ firms/ institutions or gifted to it, in the name of trust, but all the revenue and from search enterprises or business/ firms/ institutions, shall be utilized towards the charitable functions of the trust only. The above enterprises or business/ firms/ institutions shall be managed by search trustees appointed by the board of trustees as an agent/ agents of the trust.
- 17) The executive committee shall have the purchase property, sell property in the name of the trust for the benefit of the trust.
- 18) The property of trust shall be utilized only for the objectives of the trust and shall not be utilized for any other purpose.


**19) Duties of executive committee**

The executive committee shall maintain and keep in good condition the marriage hall (Kalyana Mandapam) and any other newly constructed / to be constructed building which belongs to the trust.

- a) For renovation the executive committee shall have the right to spent upto Rs.5,000/- and for more than Rs.5,000/- it must be approved by the Board of Trustees.
- b) Nominal fee fixed by the executive committee time to time shall be collected for each marriage.
- c) The marriage hall maybe let free from rent upon the genuine reason stated in the application. And the reason must be recorded by passing resolutions.
- d) The marriage hall shall be let out to all for genuine reasons and decision taken by the executive committee is final.
- e) The marriage hall maybe let out to public for cultural programs during the period marriages are not solemnized.
- f) The persons shall not stay more than 3 days in the marriage hall from the date of booking. The committee shall have the right to reduce the period.
- g) The separate register must be maintained and all the marriages solemnized in the marriage hall must be registered in it.
- h) In the marriage hall non vegetarian food must not be cooked or served.

20). The Managing trustee shall administer the day to day proceedings of the trust, maintain minute book recorded the activities of the executive committee and minute book recorded the activities of the trustees and maintain the register for the marriages solemnized. And in the absence of the managing trustee the vice president shall be in charge of the above activities.

21). In case any member or executive committee or committee president fails to perform their duty or acts against the interest of the trust, will be provided with so cause notice and if the reason is not satisfied, they may be dismissed and the trustees shall appoint a temporary committee member or president. To dismiss the executive committee and president the trustees shall conduct a special meeting. An in the special meeting 2/3 rd members of the trustees must be present (Quorum).

22) **Quorum in ordinary meeting**


There must be 1/3 Quorum for ordinary meeting and for special meeting said in para 21 for dismissing managing trust, committee and for appointment of temporary managing trustee, committee.


23) The president shall have rights to conduct meeting except special meeting, the trustees meeting shall be held on June month of every year to elect executive committee once in 3 years, to approve yearly account and annual report. The secretary shall send 14 days prior notice to each trustee mentioning the date, time, place for conducting trustee meetings. Along with the said notice annual report and the lists of income and expenditure should be sent.

24) 7 days prior notice to be given before conducting special meeting.

25) The managing trustee shall conduct special meeting within 15 days from the date of receipt application from 1/3 of the trustees. In case of failure of conducting special meeting by the managing trustee, the trustees shall conduct meeting, for this 1/3 of trustees ( Quorum ) should be present. 7 days prior notice must be given to each trustee regarding the activities of the meeting.

26) Any one of the trustee shall be excluded from the trust for the below said reasons

(a) if acts against the interest of trust and its improvement and violates the aims of the trust and spoils the name of the trust. Search trustees shall be removed from the trust by conducting special meeting 1/3 majority of the trustees.

27) The president shall have a right to suspend any one till the end of the meeting if he is found to unnecessary disturb the meeting.

28) The below 5 members are the elected advisory board

29) The trustees shall select a auditor for auditing the accounts of trust and shall fix the fee for him. Initially auditor Mr. R.Sachithanandhan.B.Com, ACA has been appointed for auditor for trust.

30). The trustee meeting activities shall be registered in a minute book and it shall be kept in charge of the secretary

31) Rs. 2,500/- and above with trust in surplus yearly shall be deposited as per Indian Trust Act and Indian Income Tax Act 1961.

32) The president and secretary shall have a right to sue or defend the trust the Court of law.

33) This deed of trust shall come in to force from the date of execution.

34) This trust shall not be change or alter .


35) The trustees shall have the right to include, exclude, amend any Act or rule of this trust.

36) This trust shall be governed by the rules of Indian trust Act 1992.

37) Nothing contained in this deed shall be deemed to authorize the trustees to do any ct which may in any way be constructed as violative or contrary to the provisions of section 2 (15), 11, 12, 12A, 13 and/or 80G of the Income tax Act, 1961 or any statutory modifications thereof and all activities of the trust shall be carried out with a view to benefit the public
